2025/2026 Application for Undergraduate Admission through Recommendation by Overseas High Schools

I. General Provisions

A. Program Duration and Graduation Requirements

They shall be individually referred to and concordant with National Taiwan University, National Taiwan Normal University, and National Taiwan University of Science and Technology (hereafter called “NTU System” abbreviated from National Taiwan University System). Applicants from overseas, Hong Kong, or Macau senior high schools with admission qualifications equivalent to the second year of senior high schools in the Republic of China are required to take additional credits apart from the graduation threshold stipulated by each university.

B. Qualification

1. Applicants graduating in the current year or graduated applicants who meet the following criteria are welcome to apply for undergraduate programs through NTU System admission:
 - a. **Overseas Chinese Students** refers to a student of Chinese descent who has come to Taiwan to study, who was born and lived overseas until the present time, or who has been living overseas for six or more consecutive years in the immediate past and obtained permanent or long-term residency status overseas. Please note that a minimum of eight consecutive years of overseas residency is required if the person is applying to study in a university department of medicine, dentistry, or Chinese medicine in Taiwan.
 - b. **Hong Kong and Macau Students** refers to students who have permanent residency of Hong Kong or Macau; and who have been living abroad for at least six consecutive years in the immediate past; and who, according to Article 4 of Laws and Regulations Regarding Hong Kong & Macao Affairs, do not have any other foreign passports. Please note that a minimum of eight consecutive years of overseas residency is required if the person is applying to study in a university department of medicine, dentistry, or Chinese medicine in Taiwan.
 - c. **Hong Kong and Macau Chinese Students with Foreign Nationality** refers to overseas Chinese students with foreign nationalities, possessing permanent residency of Hong Kong or Macau and have been living there for at least six consecutive years in the immediate past—without a household registration in Taiwan. Please note that a minimum of eight consecutive years of overseas residency is required if the person is applying to study in a university department of medicine, dentistry, or Chinese medicine in Taiwan. They can apply for admission in accordance with Article 23-1 of the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

Note: The term "overseas" refers to countries or regions other than Taiwan, mainland China, Macao, and Hong Kong. The term "abroad" refers to countries or regions other than Taiwan. The "consecutive years of overseas residency" refers to calendar years in each of which an overseas Chinese student has not spent more than 120 days in Taiwan. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days.

2. An overseas Chinese student who received assistance to be assigned to an educational institution in Taiwan who studied for less than two years because they discontinued their studies for some reason or forfeited their student status may lodge another application to come to Taiwan to study, but only one such re-application is permitted. However, if the educational institution in Taiwan where the overseas Chinese student was studying considers that the student's conduct or academic performance was unsatisfactory, or if the student violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of the regulations governing student awards and penalties, the student had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan, based on the provisions of this paragraph.
3. Hong Kong and Macau Students who studied in Taiwan for less than two years because they voluntarily withdraw their studies for some reason may lodge another application to come to Taiwan to study, but only one such re-application is permitted.
4. This admission is not open to the graduates from unincorporated Chinese schools in Myanmar and Northern Thailand, as well as overseas students in Taiwan.
5. Applicants shall meet the requirements under the "[Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan](#)" and the "[Measures for Hong Kong and Macau Residents Studying in Taiwan](#)".
6. Applicants' academic qualification shall fulfill the requirements under the "[Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education](#)" or the "[Standards for Recognition of Equivalent Educational Levels for University Admission](#)".

C. Application Procedures

Overseas high schools are welcome to recommend applicants for admission to NTU System. There is no limit on the number of applicants high schools recommend.

1. **Application Period: From Monday, August 5, 2024, 11 am to Thursday, October 3, 2024, 4 pm.**
2. Website: <https://admissions.ntu.edu.tw/apply/overseas-chinese-applications/recommendation-by-overseas-high-schools/>.

3. Only online applications are accepted. Hard copy applications will not be accepted.
4. All required documents shall be uploaded in PDF file. Only the head shot can be uploaded in JPG format. If there are any audio or video files, please upload them to a website first and provide the web link and password to access the files. Please upload the files individually; only one file for each field is accepted. If applicants have multiple files for a particular field, please combine them into one file first before uploading. The merged file shall not be larger than 10MB.
5. After recommendations were made by the high school representatives, applicants shall log in to the system with their email account and complete the application before submission. **Once the application is submitted, we do not accept any revisions under any circumstances. Please go through the application carefully before submission.**

D. Application Notes and Regulations

1. **All applicants shall be recommended by their high school to apply for the undergraduate programs through NTU System Admission. Any individual application shall not be accepted.**
2. Once the application confirmed and submitted, NTU System will not accept any documents or changes in the application after the deadline has elapsed.

4. According to “Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan” and "Measures for Hong Kong and Macau Residents Studying in Taiwan", applicants’ personal data will be sent to the following units for acquiring his/her arrival-departure records in order to process student eligibility check for Overseas Chinese Students, Hong Kong/ Macau Students, and Hong Kong/ Macau Chinese Students with Foreign Nationality: “University Entrance Committee for Overseas Chinese Students”, “Ministry of Education”, “National Immigration Agency” and “Overseas Community Affairs Council”.
5. For Applicants who have already registered or been admitted, if following a review by the Overseas Community Affairs Council or the Ministry of Education, the applicant is found unqualified as an overseas Chinese student or Hong Kong and Macau student, or if any of the submitted documents are found to be inaccurate, forged, used under false pretenses, or altered, or if the applicant’s academic qualifications are found to be invalid, then the application or admission qualifications shall be revoked, the student will be expelled from the university, or the graduate qualifications and diplomas will be revoked, and no proof of academic qualifications or attainment will be issued.

E. Required Materials and Documents

1. Applicants are required to upload the following documents to the online application system. **Academic credentials in other languages will need to be translated to Chinese or English. The translated documents will have to be notarized by your high school with institution stamp or by a registered translation agency.**

2. **Admitted applicants shall submit the original copy and translated copy of their graduation certificate and the full transcript of academic records verified by the R.O.C. overseas missions in the country/region of the issuing institution or a recommendation unit designated by the Overseas Community Affairs Council upon registration. Failure to do so will result in the cancellation of the admission offer.**

a. **Proof for Country of Overseas Residence:**

i. Overseas Chinese students shall submit the following copies as proof of identity: a copy of the ID card and passport of their country of overseas residence or a copy of their R.O.C. passport with Overseas Compatriot Identity Endorsement of their overseas residence.

ii. Hong Kong and Macau students shall submit proof of their permanent residence in Hong Kong or Macau (scanned copies of both sides are required). Applicants who are born in Mainland China, the copy of the profile page shown on your Mainland Travel Permit for Hong Kong and Macau Residents is additionally required for application.

iii. Hong Kong and Macau Chinese Students with Foreign Nationality shall submit proof of their permanent residence in Hong Kong or Macau (scanned copies of both sides are required) and their foreign passport. Applicants who are born in Mainland China, the copy of the profile page shown on your Mainland Travel Permit for Hong Kong and Macau Residents is additionally required for application.

b. **Headshot: For the student ID.** A close-up color shot of the head and shoulders (no hats) with clear background within the last 6 months. Please upload in JPG format. The dimensions should be: width of 1.5 in., height of 2 in. The photo should be in high-resolution color. The image width x height pixels should be at least 450×600 pixels. The scan resolution should be between 300 and 500 dpi.

c. **Affidavit for Eligibility of Overseas Chinese Students:** This is automatically generated by the system. Applicants applying as Overseas Chinese Students shall print out, **sign** and upload the signed copy back to the system.

d. **Confirmation for Eligibility of Hong Kong and Macau Students:** This is automatically generated by the system. Applicants applying as Hong Kong and Macau Students or Hong Kong and Macau Chinese Students with Foreign Nationality shall print out, **sign** and upload the signed copy back to the system.

e. **Non-Household Registration Declaration:** This is automatically generated by the system. Applicants applying as Hong Kong /Macau Chinese Students with Foreign Nationality shall print out, **sign** and upload the signed copy back to the system.

f. **Chinese Proficiency Certificate (equivalent to CEFR A2-level)**: All programs offered via this application portal are mostly taught in Chinese. Please submit a Chinese proficiency certificate as a proof that you have basic knowledge of Chinese language ability. We accept the following certificates:

- i. **Chinese Proficiency Certificates**: TOCFL Level 2 or HSK Level 4
- ii. **Certificate of High School Taught in Chinese**: If your high school is fully taught in Chinese, please provide school-issued relevant documentation stating that Chinese is the medium of instruction of your high school.
- iii. **Self-Statement in Chinese**: If your mother tongue is Chinese, please provide an introduction letter in Chinese outlining your day-to-day use of the language, learning progress, and your listening, reading, speaking, and writing skills.

※ *Applicants who wish to apply to NTU without the aforementioned proof of Chinese proficiency by the time of their application may still consider applying for the designated departments. If admitted by the designated department, applicants will have to study Chinese at NTU (at most 1 year) and obtain a Chinese proficiency certificate at TOCFL Level 2(CEFR A2) in order to officially begin their studies at NTU as a freshman. For the regulations, please refer to the [admissions website](#).*

g. **English Proficiency Certificate (equivalent to CEFR B2-level)**:

Applicants applying for English-taught programs are required to submit an English Proficiency Certificate to prove their English ability. We accept the following certificates:

- i. **English Proficiency Certificates**: TOEFL iBT 71, IELTS 5.5 or TOEIC 750
- ii. **Certificate of High School Taught in English**: If your high school is fully taught in English, please provide school-issued relevant documentation stating that English is the medium of instruction of your high school.
- iii. **Your previous degree was obtained from an English-speaking country**: If your high school's graduation certificate was from an English-speaking country, please provide your graduation certificate. You may provide your Certificate of Enrollment if you have not yet graduated during the application period.
- iv. **You are from an English-speaking country**: Please provide the scanned copy of your passport.

※ *Please refer to the [website](#) for the list of English-speaking countries.*

※ Applicants who wish to apply to NTU without the aforementioned proof of English proficiency by the time of their application may consider applying for the designated departments. If admitted by the designated department, applicants will have to obtain a English proficiency certificate at CEFR B2 level in order to officially begin their studies at NTU as a freshman. For the detailed list of designated departments and regulations, please refer to the [admissions website](#).

- h. **School Enrollment Certificate or the Degree/Graduation Diploma:**
- i. Applicants graduating in the current year shall upload the school enrollment certificate of the current semester stamped by the academic affairs division of the senior high school.
 - ii. The graduated shall upload the senior high school degree/graduation diploma.
- i. **Full Transcripts of High School:** Academic credentials in other languages will need to be translated to Chinese or English. The translated documents will have to be notarized by your high school with the institution stamp or by a registered translation agency.
- i. Applicants graduating in the current year: Transcripts of academic records from grade 10-11, at least four semesters, including grades of each subject, the overall average grade of each semester, class rank, and percentage class rank.
 - ii. Graduated applicants: Transcripts of academic records from grade 10-12, a total of six semesters, including grades of each subject, the overall average grade of each semester, class rank, and percentage class rank.
- j. **Official Transcript of National Entrance Examination or International Baccalaureate Grade (optional):** The categories of these transcripts include the Hong Kong Diploma of Secondary Education, the Malaysia Unified Examination Certificate (UEC), the Malaysian Higher School Certificate (STPM), the Malaysian Certificate of Education (SPM), SAT, ACT, A Level, and IBDP.
- k. **Personal Statement:** No format restricted. To be written in Chinese or English only.
- l. **Study Plan:** No format restricted. To be written in Chinese or English only.
- m. **Teacher Recommendation Letters:** Recommendation Letters shall be written in Chinese or English by applicants' teachers. It's suggested for school teachers that the recommendation letters should be honest appraisals of a student's academic performance and intellectual promise, primarily conveying the teacher's classroom experience with the student, which can provide a university an idea of how the student is likely to perform academically.

F. Application Fee

1. Application Fee: The application fee for each student is **NTD \$2,000**.
2. Payment Method: Please log in to the application system after being recommended by the high school representative and complete the payment before the deadline.
3. After the payment is completed, no refund will be given under any circumstances, including but not limited to the withdrawal of application, failure to meet requirements, mistake in the payment and/or double payment.
4. If applicants fail to pay the application fee, their application will be considered incomplete.

G. Departments' Admission Decisions

1. **Admission Decisions for admitted, conditionally admitted and waitlisted students: Thursday, December 19, 2024, 2 pm.**
2. Students should check the Admission Decisions by logging in to the application system. Admitted, conditionally admitted or waitlisted students should confirm their acceptance on time. Students who do not confirm their acceptance on time may not request remedial action based on the fact that they did not receive a notification letter or a notice.

H. Confirmation of Acceptance and Admission Decisions for Waitlisted Applicants

1. **Admitted, conditionally admitted and waitlisted students should confirm their acceptance from 2 pm on Thursday, December 19, 2024, to 2 pm on Thursday, December 26, 2024. Please log in to the application system during the designated period to confirm the acceptance.**
2. If admitted, conditionally admitted or waitlisted students fail to confirm their acceptance during the designated period, the admission qualifications of admitted students shall be revoked, conditionally admitted students and waitlisted students shall be removed from the waitlist. Subsequently, make-ups are not allowed for any reason.
3. **Admission Decisions for Waitlisted Applicants: Friday, January 3, 2025, 2 pm.** Any further substitution of places by waitlisted students will not be accepted.
4. *Admitted applicants who have accepted their admission offer, conditionally admitted and waitlisted applicants who have accepted their waitlist offers and are further admitted will not be considered for any applications through University Entrance Committee for Overseas Chinese Students for that academic year.*

3. Registration for Enrollment and Other Matters

- a. NTU is scheduled to update the information regarding registration schedule, orientation, dormitory application, and course selection for new students on the National Taiwan University New Students and Transfer Students Network under “Undergraduate Courses” for new students to review by the end of June, 2025. Admitted students should attend NTU in person on the enrollment date to complete registration according to the regulations. Students who fail to complete registration on time will not be allowed make-up registration for any reason. - b. Identity verification upon registration (to be returned following registration):
 - i. Examination of original identity documents (identity card or passport) or original Republic of China passport and Overseas Chinese Identity Certificate.
 - ii. Original senior high school graduation diploma and original senior high school transcripts authenticated by the Republic of China overseas mission in the country/region of the issuing institution or units designated by the Overseas Community Affairs Council.
- c. Students admitted to undergraduate programs from schools overseas or in Hong Kong and Macau at the equivalent level to the second year of Senior High School in

the Republic of China should take an extra 12 credits to graduate from the department.

- d. Admission letter does not guarantee the issuance of a resident visa. Visa applications must be approved by the Republic of China overseas mission.
- e. Prior to enrollment, new undergraduate students at the University are required to undergo a general physical examination. The items for examination and timing will be determined by the Health Center. The notification for the health examination will also be announced on the National Taiwan University New Students and Transfer Students Network prior to the end of June 2025 for new students to review.
- f. **According to Article 48 of the National Taiwan University Academic Regulations, “Students enrolled at the University from the 2013 academic year who are enrolled in two or more undergraduate programs at the same time” should be expelled from the University. Students must ensure that they do not violate this rule.**
- g. If it is discovered that admitted students do not meet the requirements for enrollment, or that submitted documents or certificates (including degree certificates, transcripts, extracurricular activities, or other relevant certificates) are forged, falsified, used under false pretenses, used fraudulently, inaccurate, or altered, the university shall revoke the eligibility for admission or expel students who are already enrolled. Students shall be liable for the legal consequences, and no proof of studies shall be issued. If this is discovered after the student has graduated from the university, aside from repealing the student's graduation certificate, an announcement shall be made revoking the student's legibility for graduation.
- h. Following enrollment, if departments have requirements on taking certain courses, students should select courses according to these regulations. To select courses, students shall follow program requirements under NTU Regulations after enrolling to NTU.
- i. For any appeals to the admission result, applicants may submit a written statement to the Office of International Affairs within 14 days after the announcement of the admissions results. Office of International Affairs should provide a formal response within one month of receiving the complaint, and should form a task force for impartial investigation if necessary. If students are unsatisfied with the outcome of the appeal to the Admissions Committee, they may seek an administrative remedy in accordance with the law.
- j. Issues not covered by the admission guidelines are either prescribed in relevant University regulations or left to the discretion of the Admissions Committee.

4. Tuition Fees and Dormitory Accommodation

- a. - d. If admitted students are found to have submitted forged, fraudulent, or falsified documents, and this is verified following investigation, the admission status will be revoked. Students who have already enrolled shall have their student status revoked, and no proof of study shall be issued. If this is discovered following graduation, qualifications shall be revoked, and the graduation certificate shall be recovered or revoked.
- e. If students have any objections to the results or other matters related to the test, they should note the specific grounds in writing and provide supporting documentation to the Admissions Committee within 10 days of the release of results. The objection will be handled by the University in accordance with relevant regulations. Unidentified objections will not be processed.

- f. If an admitted student violates the law prior to enrollment and the offense is serious, the student's admission qualifications shall be revoked following confirmation of the facts by the University's Admissions Committee.
- g. Issues not covered by the Guide will be handled according to relevant academic regulations or by a decision of the Admissions Committee.

2. Tuition and Dormitory Accommodation

- a. Tuition Fees: after the tuition fees of the University for the 2025/2026 academic year have received approval from the Ministry of Education, they shall be posted on the University's Tuition Fees website. - b. Dormitory Accommodation: NTUST provides accommodation for overseas freshmen students. In-campus Dormitory for and six-person are available for accommodation with fee standard NT\$6,800~NT\$16,000 per semester for each student. The dormitory regulations and fees shall be followed and concordant with the up-to-date announcement on the school website.
